A yes vote will indicate to the Excelsior Town Board that the electors favor the Board borrow money to improve North Reedsburg Road at the intersection with Vogel Road at an estimated cost of \$200,000.00

A no vote will indicate to the Excelsior Town Board that the electors are not in favor of Board borrow money to improve North Reedsburg Road at the intersection with Vogel Road at an estimated cost of \$200,000.00.

Introduced and adopted by the Town Board of the Town of Excelsior, Sauk County, Wisconsin this 13th day of December, 2017.

The question will appear on the ballot as follows:

"Should the Excelsior Town Board borrow money to improve North Reedsburg Road at the intersection with Vogel Road at an estimated cost of \$200,000.00?
