

**VOTING BY ABSENTEE BALLOT**  
**For the April 6, 2021 General Election**  
**Type E Notice**

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, and who has resided in the ward or municipality where he or she wishes to vote for at least **28** consecutive days before the election. The elector must also be registered to vote to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

**You must make a request for an absentee ballot in writing or online at MyVote.wi.gov.**

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter or you may apply for an absentee ballot online at MyVote.wi.gov. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, your signature. You may make application to your municipal clerk for an absentee ballot by mail, email, fax or online at: MyVote.wi.gov.

**Making a request for an absentee ballot by mail**

**The deadline to request an absentee ballot by mail is:** 5:00 pm Thursday, April 1, 2021. For regular and overseas voters.

**Note:** Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

**The first day to vote an absentee ballot in the clerk's office for the April 6, 2021 Spring Election is Tuesday, March 23, 2021. Contact your municipal clerk for your municipality dates and times.**

**The last day to vote an absentee ballot in the clerk's office is Friday April 2, 2021. Contact your municipal clerk for your municipality dates and times.**

**Note:** This is a multiple Shared Notice. Please Contact your municipal clerk for your municipality in office absentee voting days, times, or by appointment or appointment only in clerk's office.

No in-person absentee voting may occur on the day before the election.

The municipal clerk will deliver voted ballots returned on or before Election Day to the proper polling place or counting location before the polls close on April 6, 2021.
